SYNERGY S.A. ("D.D. SYNERGY") through the acquisition of the remaining minority stake of 49.9%, for a consideration amounting to €3.5 million.

D.D. SYNERGY, founded in 1999, is one of the largest SAP business partners in Greece, providing tailored SAP solutions that address the specific needs of modern enterprises in Greece and abroad. It is noted that, in April 2024, Qualco acquired a 50.01% majority stake in D.D. SYNERGY.

The acquisition attests to Qualco Group's strategic vision to accelerate and broaden D.D. SYNERGY's growth and activities. Its full integration into the Group's ecosystem enables the seamless creation of synergies across the organisation's companies to deliver large-scale technology projects and expand into new sectors with innovative product solutions.

This transaction forms part of the implementation of the strategic plan presented upon Qualco Group's listing on the Athens Exchange, and it lays the foundations for the following targeted steps in inorganic and organic growth.
