On 4 December 2025, AIAG acquired 230,374 ordinary shares of the Company (ISIN GRS419003009) at an average price of EUR 18.0798 per share, for a total consideration of approximately EUR 4,165,115.85. The transaction was executed on the Athens Stock Exchange and on private trading venues operated as Multilateral Trading Facilities (MTFs).
