On 7 January 2026, AIAG acquired 408,341 ordinary shares of the Company (ISIN GRS419003009) at an average price of EUR 18.7410 per share, for a total consideration of approximately EUR 7,652,718.68. The transaction was executed on the Athens Stock Exchange and on private trading venues operated as Multilateral Trading Facilities (MTFs).
