

Release of Regulated Information pursuant to Article 19 of Regulation (EU) No 596/2014

Transaction Notification

“OPAP S.A.” (the “**Company**”), announces, pursuant to Article 19 of Regulation (EU) No 596/2014 and the relevant provisions of Greek law, that on 4 February 2026 it received a notification from “Allwyn International AG” (“**AIAG**”), a legal person closely associated with the following members of the Board of Directors of the Company:

in relation to the following transactions in shares of the Company.

On February 2, 2026, AIAG acquired 398,806 ordinary shares of the Company (ISIN GRS419003009) at an average price of EUR 17.5165 per share, for a total consideration of approximately EUR 6,985,685.30. Simultaneously, the shares acquired will be used to partially settle the open positions of the share forward transaction disclosed on December 22, 2025.

On February 3, 2026, AIAG acquired 302,472 ordinary shares of the Company (ISIN GRS419003009) at an average price of EUR 17.6785 per share, for a total consideration of approximately EUR 5,347,251.25. Simultaneously, the shares acquired will be used to partially settle the open positions of the share forward transaction disclosed on December 22, 2025.

On February 4, 2026, AIAG acquired 389,818 ordinary shares of the Company (ISIN GRS419003009) at an average price of EUR 17.8520 per share, for a total consideration of approximately EUR 6,959,030.94. Simultaneously, the shares acquired will be used to partially settle the open positions of the share forward transaction disclosed on December 22, 2025.

The purchases of ordinary shares were executed on Athens Stock Exchange and private trading venues operated as Multilateral Trading Facilities (MTFs), whereas the transactions of partial unwind of the share forward was executed OTC / outside the trading venue.
