## 10. Additional information<sup>xvi</sup>:

This notification shall correct and replace the major holding notification that had been erroneously made by Mr. Karel Komárek on 27 March 2026. VALEA FOUNDATION has no shareholders and is not controlled by any person; the Board of Directors of VALEA FOUNDATION decides at its sole discretion, without receiving instructions from its beneficiary or from any other person, on the exercise of the voting rights of VALEA FOUNDATION in the undertakings it controls. Mr. Karel Komárek is the sole beneficiary of VALEA FOUNDATION, but he does not control VALEA FOUNDATION within the meaning of the Luxembourg law of 11 January 2008 on transparency requirements in relation to information about issuers whose securities are admitted to trading on a regulated market. This notification is made in accordance with articles 9(e) and 11(3) of the Luxembourg law of 11 January 2008 on transparency requirements for issuers, in relation to: (i) subscription by Allwyn International AG of 445,684,184 new common shares issued by Allwyn AG; (ii) the contribution by Allwyn International AG of part of its indirect holdings in Allwyn AG to Allwyn AG through a transfer of its assets to Allwyn AG. As a result of the contribution 9,528,742 common shares issued Allwyn AG are now held in treasury by Allwyn AG through a subsidiary, Allwyn Greece & Cyprus Holding Ltd (formerly Sazka Delta Hellenic Holdings Limited); and (iii) the transfer agreement recording the transfer of 26,972,968 common shares issued Allwyn AG from Allwyn International AG to J&T in exchange for 51,130 shares issued by Allwyn International AG being transferred to Allwyn International AG. After setting off the transactions described under items (i) to (iii) above, the position held directly by Allwyn International AG in Allwyn AG amounts to 604,392,847 common shares as of the date of this notification. The percentages of voting rights have been rounded automatically by the eRIIS system of the CSSF, calculation may therefore display a discrepancy when manually added without consideration to rounding.

<sup>iv</sup> This should be the full name of (a) the shareholder; (b) the natural person or legal entity acquiring, disposing of or exercising voting rights in the cases provided for in Article 9 (b) to (h) of the Transparency Law; or (c) the holder of financial instruments referred to in Article 12(1) of the Transparency Law.

- in the circumstances foreseen in letter (c) of Article 9 of that Law, the natural person or legal entity holding the collateral, provided the person or entity controls the voting rights and declares its intention of exercising them, and natural person or legal entity lodging the collateral under these conditions;
- in the circumstances foreseen in letter (d) of Article 9 of that Law, the natural person or legal entity who has a life interest in shares if that person or entity is entitled to exercise the voting rights attached to the shares and the natural person or legal entity who is disposing of the voting rights when the life interest is created;
- in the circumstances foreseen in letter (e) of Article 9 of that Law, the controlling natural person or legal entity and, provided it has a notification duty at an individual level under Article 8, under letters (a) to (d) of Article 9 of that Law or under a combination of any of those situations, the controlled undertaking;
- in the circumstances foreseen in letter (f) of Article 9 of that Law, the deposit taker of the shares, if he can exercise the voting rights attached to the shares deposited with him at his discretion, and the depositor of the shares allowing the deposit taker to exercise the voting rights at his discretion;
- in the circumstances foreseen in letter (g) of Article 9 of that Law, the natural person or legal entity that controls the voting rights;
- in the circumstances foreseen in letter (h) of Article 9 of that Law, the proxy holder, if he can exercise the voting rights at his discretion, and the shareholder who has given his proxy to the proxy holder allowing the latter to exercise the voting rights at his discretion (e.g. management companies).

- <sup>v</sup> *Applicable in the cases provided for in Article 9 (b) to (h) of the Transparency Law. This should be the full name of the shareholder who is the counterparty to the natural person or legal entity referred to in Article 9 of that Law unless the percentage of voting rights held by the shareholder is lower than the 5% threshold for the disclosure of voting rights holdings (e.g. identification of funds managed by management companies).*
- <sup>vi</sup> *The date on which threshold is crossed or reached should be the date on which the acquisition or disposal took place or the other reason triggered the notification obligation. For passive crossings, the date when the corporate event took effect.*
- <sup>vii</sup> *The total number of voting rights shall be composed of all the shares, including depository receipts representing shares, to which voting rights are attached even if the exercise thereof is suspended.*
- <sup>viii</sup> *If the holding has fallen below the 5% threshold, please note that it is not necessary to disclose the extent of the holding, only that the new holding is below that threshold.*
- <sup>ix</sup> *In case of combined holdings of shares with voting rights attached "direct holding" and voting rights "indirect holding", please split the voting rights number and percentage into the direct and indirect columns - if there is no combined holdings, please leave the relevant box blank.*
- <sup>x</sup> *Date of maturity/expiration of the financial instrument i.e. the date when right to acquire shares ends.*

In case of multiple chains through which the voting rights and/or financial instruments are effectively held the chains have to be presented chain by chain leaving a row free between different chains (e.g.: A, B, C, free row, A, B, D, free row, A, E, F etc.). Numbers shall be attributed to all persons or entities within the group in column 1 in order to allow a clear indication of the control structure in column 6. The names of all undertakings of the control chain shall be provided in column 2, even if the number of the directly held voting rights and/or financial instruments is not equal or higher than the notifiable threshold. Columns 3 & 4 shall indicate the holdings of those persons or entities directly holding the voting rights and/or financial instruments if the holding is equal or higher than the notifiable threshold.*
- <sup>xv</sup> *The names of controlled undertakings through which the voting rights and/or financial instruments are effectively held have to be presented irrespectively whether the controlled undertakings cross or reach the lowest applicable threshold themselves.*
- <sup>xvi</sup> *Example: Correction of a previous notification.*
