During his career, he held senior investment roles at the Baupost Group, Citigroup, and J.P. Morgan. At Trastor, Mr. Golebiowski brings deep experience in investment strategy, capital raising and scaling of platforms, and portfolio optimisation to support the Company's next phase of growth.
